MINUTES OF THE MEETING OF MILEHAM PARISH COUNCIL HELD AT THE VILLAGE HALL ON TUESDAY 25th June 2019 @ 7.30PM

1. Apologies for absence

District Councillor M. Kiddle-Morris sends his apologies as he has two other Parish Meetings that he needs to attend.

County Councillor T. Carter sends his apologies as he is not able to attend.

2. Declarations of Pecuniary Interest

There were no DPIs.

3. Minutes of the Previous Meeting.

Councillor Harmer and Councillor Powell, seconded the resolution that the minutes of the meeting on 20th May 2019, having been circulated be approved. All were in favour and the minutes were duly signed by the Chairman.

4. Public Participation

Nothing was reported.

5. Mark Henderson from Norfolk County Council and Nathalie Harris, Assistant flood risk officer, was invited to discuss the Mileham Local Flooding Plan

The report that was released in 2018 "Investigation into the Flooding Mileham. This report can be viewed on the internet by google searching the title.

Mark Henderson confirmed that the flooding in Mileham is a combination of factors which has seen three major floods in 2016, 2017 and 2018. The flood in 2018 was due to lots of water falling which is something that would probably only happen once in 146-year period. If we keep the ditches well maintained, then it could prevent the blockage to the drains. It was recommended that more tree planting would also help.

The Parish Council would like all Villagers to monitor the drains, ditches outside their properties and any blockages that are not privately owner (privately owned means: watercourses or a main river running through your land or along the boundary of your property) to inform the Parish clerk who will report these to Norfolk County Council. If you do have a watercourse or ditch running through your property, please see Mileham website for a leaflet how you can maintain your ditches and drains. The Leaflet is title "Guidance notes for Riparian owners".

6. Matters for Report

6.1 Flooding to the West of Mileham-

The Councillors thanked our flooding co-ordinator for all her help and support with liaising with the Parish Council and Norfolk County Council. The drainage ditches are already full of surface water, so when we have further rain water it is going to flood. We would still like to encourage Parishioners to take photos for evidence.

- **6.2 Speedwatch-**The speed watch co-ordinator for Mileham, reported that not enough people have come forward to volunteer. We have only two confirmed, it is essential to monitor our speeding through our village. We do require more than 6 volunteers, The Clerk has advised it on Facebook, church and Village, website and posters around the village. The SAM2 sign is a deterrent and as it is a shared unit, Mileham will only have use of it 3 times a year.
- **6.3 Defibrillator-** The clerk reported that she had received an email apologizing for the delay, and this was due to the Cabinet manufacturer moving premises.

6.4 Mileham School and Land Sale

The sale of the school and playing field have not progressed any further and it is expected to take some months to resolve issues with the Charity Commission.

6.5 Upkeep of Village Playing Fields and appoint a Sub-Committee.

A Parishioner has very kindly come forward to volunteer to be a member of the Sub-committee and 3 other members have also volunteered to complete a full sub-committee. They will all communicate with each other and contact the Parish Council with ideas and an action plan.

The clerk reported that all matters reported previously are pending still and will follow up with Breckland Council.

The clerk reported that all new pot-holes have been reported and all have been actioned.
